UPDATE: GROUP HEALTH FOR INDEPENDENT PRACTICES

MLHPP and DVACO have determined there is sufficient support in favor of exploring the feasibility of offering a group health insurance plan to independent practices participating in our network. Legal review is underway and research will begin soon. A decision should be reached by September 30, 2018, with the earliest anticipated start date of January 1, 2019.
